
# "Raw materials prices are increasing by 30% and expected to rise further with reduced slaughter:

## 'Chairman, IFLMEA proposes exclusive Leather Fair for International Designers'

Shri KR Vijayan, Chairman, Indian Finished Leather Manufacturers & Exporters Association (IFLMEA) in his opening remarks expressed optimism for the Finished Leather Exports from India and said that beginning March 2021, there would be revival for the Industry.

The Chairman appealed to Shri Panaruna Aqeel Ahmed, Chairman, Council for Leather Exports (CLE) to support the organization of an International Leather Fair for International Designers: an idea that IFLMEA has been toying for a while now. The Chairman of IFLMEA sought support measures of the Government of India. He took this opportunity to thank Chairman, CLE; Regional Chairman (South), CLE and the Executive Director of CLE who were working relentlessly for the growth of the Industry. Shri Vijayan thanked Dr KJ Sreeram, Director, CSIR-CLRI for the new norms of finished leather as well as for the testing and quality standards. He mentioned that members of IFLMEA were benefitting from the TA Wahid & IFLMEA co-operation and the admissions to B. Tech (Leather Technology) course at Anna University. The partnership with Solidaridad for 'solid waste management' would cover Ranipet and Pallavaram tanneries. He then spoke about the LWG certifications services being offered by IFLMEA to its members, as also on traceability and sustainability. He spoke on how the CILTAA and Industry linkage helped in outreach.

The Chairman thanked Shri Panaruna Aqeel Ahmed, Chairman, CLE; Dr M Rafeeque Ahmed, President, AlSHTMA, Shri M Mohammed Hashim, doyen of the Indian Leather Industry; Shri Israr Ahmed Mecca, Regional Chairman (South) CLE; Shri N Shafeeq Ahmed, former Chairman, IFLMEA; office bearers and Executive Committee members for their unconditional support and expert advice. In conclusion, the Chairman of IFLMEA once again reposed faith that the Industry would bounce back soon!

**Chairman, CLE; Shri Panaruna Aqeel Ahmed** in his remarks, appreciated the performance of Chairman of IFLMEA despite the COVID challenge. While mentioning that Germany, UK and Italy were in the second lockdown; he alerted the Members to be prepared for the third wave as well. There is a 29.8% fall in exports as of November 2020 said, Chairman, CLE.

Shri Aqeel Ahmed also thanked former Chairman of IFLMEA, Shri N Shafeeq Ahmed for his tireless work on the revision of norms. He suggested to revise the norms every 2-3 years and to not wait for ten years, In fact, Chairman, CLE suggested that IFLMEA should start now for the next revision.

Shri Aqeel Ahmed appreciated the role of CLRI in developing an Indian Footwear Sizing System, norms for finished leather and BIS standards.

He announced that Feng Tay has become a member of CLE and now their exports too would be under the umbrella of LCE membership.

Chairman, CLE appealed to the members to benefit from the opportunity that the Mega Leather Cluster coming up at Bargur has to offer.

Among other points, he advised members to utilize the IFLADP scheme, invest in new technologies like Zero Waste Discharge (ZWD). About salt disposal, Chairman, CLE assured that this project will be taken up by CLE.

He added that records of CLE show that Leather Footwear exports is on the rise despite the growth of the non-leather footwear.

Leather Mark is the next important project to be taken up by IFLMEA and CLRI jointly, said the Chairman. CLE would support the endeavour.

In conclusion, Chairman, CLE hoped that Year 2021 would be great!

Dr M Rafeeque Ahmed, President, All India Skin & Hide Tanners and Merchants Association (AISHTMA) spoke on the following points:

Formal Shoes are not as much in fashion as more casual shoes are preferred and this, said Dr Rafeeque Ahmed, is a challenge for manufacturers of light leathers (Goat and Sheep tanners). Sheep would still be absorbed, but goat tanners will have a hard time, and this necessitates new developments.

Any shoes made for the local market should also go through ISI as per WTO. Indian players are afraid, but WTO wants level-playing field.

President, AISHTMA appreciated the work done in improvement of CETP's.



### "CLRI is always available and will work together with the Industry"


